TERMS AND CONDITIONS

- All art and craftwork must be handmade by you.
- Vendors may not display, sell, or give away materials that contain any advocacy or disparagement of a political party, political viewpoint (either historical or contemporary), candidate, or public figure. Any vendor or festival participant found violating this policy will be asked to leave the festival immediately, with no refund made.
- Sale, raffle, and/or display of assault rifles/automatic weapons is **prohibited** on festival grounds.
- Vendors are not allowed to give out free water, food, or beverages.
- **No alcohol or controlled substances are allowed on festival grounds.**
- Booth set-up must be completed by 9:30am the day of the event, and break-down must be completed by 6pm.
- If for any reason you decide not to participate after having paid for a booth, no refund will be made.
- If for any reason your vendor application is not accepted, your booth fee will be refunded by mail, minus a \$5.00 processing fee.
